- a) Contract value up to Rs. 1.0 lakh
- b) Contract value above Rs. 1.0 lakh and up to Rs. 5.0 lakh
- c) Contract value above Rs. 5.0 lakh and up to Rs. 50.0 lakh
- 3.0 The applicant is requested to tick the category he is applying for. The applicants who wish to apply for more than one category shall submit separate application forms.

 - The firm should have minimum 5 years' experience in the respective field applied for.
 - The Architectural consultants should have during immediate last five years ending on 31.12.2024 completed (i) at least one project where the fee received is minimum 80% of the upper limit in the category applied for OR (ii) at least two project where the fee received is minimum 50% of the upper limit in the category applied for OR (iii) at least three projects where the fee received is minimum 40% of the upper limit in the category applied for.
 - The architectural consultant should be member of Council of Architecture. If the firm is a partnership firm or limited company then at least one partner / director shall be member of Council of Architecture.
 - The average annual financial turnover of the firm for the last 3 (Three) years ending 31st March of the previous financial year should be at least 2 times the upper limit in the category applied.
 - The architectural consultants should have PAN & GST numbers.
 - The firm must have executed work for foreign / private / public sector banks or public / private sector organisation having office in Mumbai / Navi Mumbai and have to show case the work done for such organisation. The firm must have office / branch in Mumbai/ agglomeration areas of Mumbai.

- 3. The application shall be signed by the person/s on behalf of the organization having necessary Authority / Power of Attorney to do so. Each page of the application shall be signed and copy of Power of Attorney / Memorandum of association (Wherever applicable) shall be furnished along with application.
