We had floated e-tender (Online Mode only) pertaining to Construction Boundary Wall & Tube Well at RSETI Building Jalpaiguri RO/JALP/GAD/2024-25/239 dated 21 Feb 25 on bank website <https://www.centralbankofindia.co.in/en/active-tender> and <https://centralbank.abeprocure.com/EPROC/> and local newspapers Aajkal & Times of India North Bengal edition dated 22/02/2025. The Tender Closed on 17 Mar 25 at 03:00PM. The tender open date was 17 Mar 25 at 03:30 Pm and we have found that no bidder has bidden upto the closing time.

Again have received an approval of extension of timeline of Tender for Construction of Boundary Wall & Tube Well at RSETI Building Jalpaiguri for floating online from BSD Zonal Office Kolkata vide ZO/ BSD/ CIVIL/ KOL/ 2024-25/ 118 dated 20/03/2025 and according the last date and time for bid submission was extended from 27 Mar 25 to 05 Apr 25 upto 3:00 PM. This time only two bider has submitted the tender form. Some more Bidders have approached us that they could not able to submit the tender papers due to technical difficulties so to encourage more bidder and ensure the successful execution of the project the following modifications have been approved by competent authority:-

- Extend the last date for tender submission by 10 days.
- Relax the eligibility criteria to allow participation from contractors of neighbouring states in addition to those from West Bengal.
- Last date and time for bid submission extended:- FROM 10 Apr 2025 TO 19 APR 2025 up to 3:00 PM
