7. **Earnest Money Deposit of ₹ 10,000/- (Rupees Ten Thousand Only) per vehicle for General Public and ₹ 5,000/- (Rupees Five Thousand Only) for Staff and Ex-staff shall be paid along with the offer in the form of Account Payee Demand Draft drawn in the favour of Central Bank of India and payable at Chandigarh, Fixed Deposit Receipt, Banker's Cheque or Bank Guarantee from a Nationalized/ Scheduled Bank located in Page 3 of 5 India, OTHER THAN CENTRAL BANK OF INDIA and EMD(s) must be enclosed with EACH Bid. 8. **In case of no response from H1 bidder or if the H1 bidder refuses to accept the vehicle bid for due to any reason, the EMD shall be forfeited and offer will be extended to H2 bidder (H2 to match the rate of H1). Similar procedure shall be followed in respect of H2 / H3 etc. as long as the Bank is able to get a price above the Reserve Price. Vehicle shall not be disposed-off below the Reserve Price.**

j) The Bidder has to sign each page of the Tender being submitted.


