2. The E-Auction will take place through portal <https://ebkcray.in> on 27/08/2024 from 10:00 AM to 6:00 PM with auto extension of 10 minutes, Date & Time of Inspection 22/08/2024 from 10.00 AM to 4.00 PM.
3. Interested bidders may deposit pre-bid EMD with Ebkcray before the close of e-auction. Credit of pre bid EMD shall be given to the bidder only after receipt of payment in Ebkcray's bank account and update of such information in the e-auction website. This may take some time as per banking process and hence bidders, in their own interest, are advised to submit the pre-bid EMD amount well in advance to avoid any last minute problem.
